The 2015 Annual Meeting of Shareholders of DLH Holdings Corp., will be held at the New York Marriott Downtown, 85 West Street, New York, NY 10006, on February 12, 2015, at 10:00 AM (local time).

Proposals to be considered at the Annual Meeting:

- (1) To amend the Company's Amended and Restated Certificate of Incorporation to declassify the Company's Board of Directors;
- (2) If Proposal 1 to declassify the Board of Directors is approved, to elect the seven Directors nominated by the Board of Directors to serve until the 2016 Annual Meeting.
- (3) If Proposal 1 to declassify the Board of Directors is not approved, to elect the two Class 1 Directors nominated by the Board to serve for a three year term ending 2018
- (4) An advisory vote regarding the approval of compensation paid to our named executive officers;
- (5) Ratification of the appointment of WithumSmith + Brown PC, as the Company's independent registered public accounting firm for the 2015 fiscal year; and
- (6) The transaction of such other business as may properly be brought before the meeting or any adjournment thereof.

The Board of Directors recommends a vote "for" all the nominees for election to the board of directors listed in the Company's 2015 Proxy Statement, and "for" all the other Proposals included in the 2015 Proxy Statement.
