ANNEXED EXPLANATION SHEET

On January 25, 1999, the Company acquired 10 privately held entities operating under the tradename the Teamstaff Companies. The Company's report on Form 10K will reflect the operations of the combined entities since January 25, 1999. Since such date, management of the combined entities have been consolidating and coordinating their operations, including information and financial systems. The Company is unable to file its Form 10K for the fiscal year ended September 30, 1999 without unreasonable expense and effort due to its inability to complete the compilation of all necessary financial information due to these management and operational charges.

PART IV. (3)

For the fiscal year ending September 30, 1998 the Company had revenues of \$139,675,000 as compared to \$244,830,000 for the current year end. The revenues for the year ending September 30, 1999 reflect the acquisition of the 10 Teamstaff Companies which was effected on January 25, 1999. The Report on Form 10K for the year ending September 30, 1999 will reflect this acquisition. The Company's report will also reflect costs of the Team Staff acquisition and an increase in the Company's debt resulting from an increase in the Company's lending facilities. Selling, general and administrative expenses have also increased from \$7,389,000 in the year ending September 30, 1998 to \$12,181,000 in the present year. There increases on the result of higher costs associated with higher sales.
